

**RESERVATIONS:** Our trained Resort Reservations Specialists are happy to assist with selecting and booking appointments. Please make reservations two weeks in advance to ensure that your child receives desired services and appointment times. Same day appointments will be accepted based on availability.

**YOUR CHILD'S SAFETY:** When a guest is left in our care, we will require the parent or guardian picking up the child to show identification if the person picking up the child is not the one that dropped him or her off. A release form will be provided upon check-in.

Please be advised that all spa treatments are performed in communal and/or semi-private space. This allows for personalized attention as well as discretionary supervision. A parent or guardian must accompany all children ages 5-8 for the duration of their spa visit.

Swimsuits or shorts and a sports top (for girls) are required for all massages. Massages and facials will be performed by a female therapist. Parents are invited to accompany children during treatments (required for ages 5-8).

Upon making reservations or any time prior to spa check-in, please inform our staff of any medical conditions, allergies and/or medications that may influence or affect your child's spa experience.

**CANCELLATION POLICY:** We realize that circumstances arise that may prevent you from keeping scheduled spa appointments. If you must cancel or change your reservations, please notify us at least 24-hours prior to your scheduled appointment time(s) to avoid a cancellation fee, which is equivalent to the total cost of each service.

**GRATUITIES:** For your convenience, a 20% service charge will be added to all services inclusive of gratuity and tax. This amount is adjustable based on your level of satisfaction.

ARRIVALS AND DEPARTURES: Please arrive 10 minutes prior to the scheduled start time of your child's first appointment to allow ample time for check-in. Modifications to service duration may be necessary should your child arrive late. Parents or guardians are expected to arrive to pick up their child(ren) 5 minutes before the end of the final scheduled appointment time. Late pick-ups will result in additional fees.
